## of Using the Corporate Identity (CI)

# The Basic Version

---

The basic presentation form of the logo consists of the title JABLOTRON that contains the JABLOTRON symbol (letter O) in connection with the supplementary text CREATING ALARMS. The primary full-colour version can only be used on a white or very light background. It is recommended to use the black and white version when printing in black and white. The logo cannot be used without the supplementary text (creating alarms).



## Other Versions

---

If the background on which the logo is placed has a different colour than white or very light, it is possible to use one of the following versions that presume a neutral background (black or grey) or a potential adjustment of the background to the company colours. It is not allowed to use other colours.



## Colours


Main, but also the additional colours should be used (including black and white) as follows. All the colours cannot be modified in their intensity (lighter or darker).

# Zone of Protection





## Support

---


In relation to quality and systematic presentation, it is recommended to use a supplementary element in the form of a bullet generated from the JABLOTRON symbol in addition to the basic specification (use, colours, zone of protection, font). Other colours than those given below are not allowed.

# Spreading a Uniform CI – Identification

## Identification – shop, vehicle

Basic symbol referring to JA (logo with additional text), the basic description of activities (Security systems) and the partner relationship to JA (wholesale representation) in 3 possible types.

### Light Identification

A light board executed in the dimensions of 700 x 429 mm. The size of the identification may be adjusted in the case of some objective reasons (e.g. limited space).

### Tarpaulin Identification

Tarpaulin identification is another form of support of identification or a version for use in spaces where it is not possible to place a light board (individual sizes according to availability)


### Stick-on Identification

It is possible to use stick-on identification as another form of support or in the case of inconvenience use of the 2 aforementioned cases (individual sizes according to availability)



## Identification – WWW

Static banner executed in the recommended minimum size W 200px x H 123px.




