

# CONSENT TO PERSONAL DATA PROCESSING

**I CONSENT** to the processing of my personal data within the meaning of Act No. 101/2000 Coll., on Personal Data Protection, as amended, and in compliance with Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data provided to:

**JABLOTRON ALARMS a.s.**, Company ID No.: 286 68 715, (hereinafter referred to only as the "Administrator") with its registered office at Jablonec nad Nisou, Pod Skalkou 4567/33, Postcode 466 01, file ref. B 1957 maintained by the Regional Court in Ústí nad Labem,

**within the scope:** name, surname, e-mail address, telephone number, country, field of interest

**for the purpose of:** marketing and commercial activities of the Administrator or its related parties from the JABLOTRON Group, i.e. in particular the sending and display of commercial messages and offers relating to their products and services, invitations to events which are organised and training sessions;

**for the period of:** 3 years from the date provision of the consent. If at this time I start using the products or services of the Administrator or entities from JABLOTRON Group, then for the time of their use and the next 1 year.

**I HAVE ALSO BEEN INFORMED** of the fact that:

- the Administrator will use information systems and their respective hardware as a means of processing my personal data,
- personal data will be processed in an automated and manual manner by the employees of the Administrator or authorised external processors.
- personal data may, in the above-mentioned scope and for the same purposes, only be provided to related parties in the JABLOTRON Group;
- no other third party will be allowed access to the personal data (with the exception of any obligation imposed on the Administrator by law or a final ruling issued by law),
- I can retract the consent I have given at any time in writing,
- I am entitled to information about which personal data is being processed about me by the Administrator, the purpose and manner of this processing and I am entitled to its correction or deletion.

If I were to discover or believe that processing my personal data by the Administrator is being performed at variance with the law or outside the framework of the consent I have given (period and purpose), I may demand an explanation by the Administrator or demand a remedy to the defective state of affairs and where applicable submit a complaint to the supervisory state administration authority.

**I DECLARE** that the data provided to the Administrator is true and accurate.

**I DECLARE that I give this consent consciously and completely voluntarily and that I am aware that I may at any time retract or restrict this consent in writing, or request deletion of my personal data.**

The above data will be used by JABLOTRON ALARMS solely for the purpose of processing your request. The data may be processed in an automated manner or manually by employees of the Administrator or authorised external processors.

Depending on the nature of your query, your consent together with your personal data as specified may be passed on to selected related entities within the JABLOTRON group (typically JABLOTRON SECURITY a.s., JABLOTRON LIVING TECHNOLOGY s.r.o.).
